With aim to enhance the transparency and popularity of sustainable and green investment products, on 1 December 2020, the Hong Kong Stock Exchange announced the official establishment of the Sustainable & Green Exchange (STAGE). Laura May-Lung CHA, the Chairman of the Hong Kong Stock Exchange, mentioned that "green finance is a cornerstone of future global sustainability and a powerful engine of economic and social growth. Hong Kong Stock Exchange is committed to promoting sustainability and the development of financial products that underpin the global resiliency of financial markets". [1] It is clear to say that ESG will be the core priority for various industries in the future and shall not be ignored.


