#### FUTURE PROSPECTS AND STRATEGIES

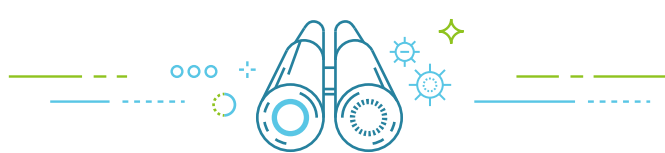
